Key Purpose

To promote the highest levels of achievement for all students through the promotion of inspirational teaching and learning.

To lead, develop and monitor the curriculum so as to maximise the achievement of all students.

The successful candidate will teach within their department or a related department.

Duties & Responsibilities

A	Deputy Head of Department are responsible to the Head of Department for the organisation and teaching of their subjects in accordance with curricular policy laid down by the principal.
B	To monitor the performance of the students and develop strategies alongside the Curriculum Manager to improve retention, attendance and achievement where necessary.
C	To develop and maintain a close working relationship with the progress team, Learning Leaders and Digital Leaders to plan effective strategies for tackling student underachievement or attendance issues.



D	To develop, implement and monitor strategies to increase the value added achieved by the team.
E	To plan and monitor the development of clear and comprehensive schemes of work and high-quality assignments for all of the curriculum programmes.
F	To effectively lead and develop particular programmes. To be proactive in the monitoring of student progress, including attendance and assessments – such as IV and sample preparation.
G	To support the Head of Department in effectively deploying staff to deliver the curriculum.
H	To work with the Head of Department to drive the establishment of working relationships with external agencies.
I	Where appropriate to manage, develop and coach a group of staff and lead on curriculum area meetings, staff training and professional development.
J	Take reasonable care for the Health and Safety of self and others who may be affected by acts or occasions related to your work.
K	Other such relevant and appropriate duties as the Head of Faculty or Head of College shall require from time to time.
